## Where your Gift Goes

Estate gifts, not designated for a specific use, are placed in the Foundation's permanent endowment to assure the Foundation's ability to serve those in need in perpetuity.

*Our mission is to provide vision and hearing services through education, detection, prevention and treatment. Through collaborative partnerships we enable greater independence and increased quality of life for Georgians in financial need.*

We provide eyeglasses, eye surgeries and hearing aids allowing people to see and hear again. We can do this because our partner medical providers greatly discount their services for the Lighthouse, at a combined value of \$5 for every \$1 we spend. In addition, the Lighthouse Foundation sends 100,000 pairs of recycled eyeglasses to developing countries each year.

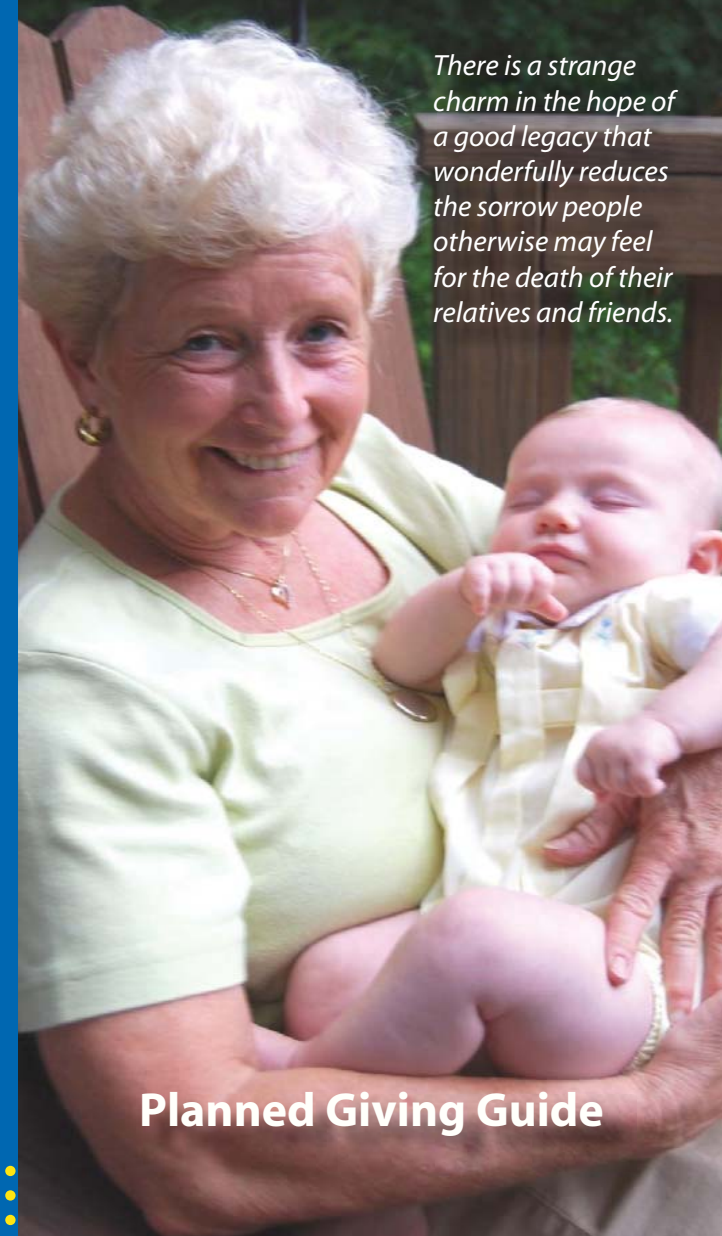

## Ways to Give

There are many ways to give. Please contact the Lighthouse if you are interested in more information on the tax benefits of the options below.

### Memorial Directive

You may choose to designate the Georgia Lions Lighthouse Foundation as a memorial gift recipient in lieu of flowers. By filling out the Lighthouse Memorial Directive Form you will become a part of the Lighthouse's legacy society.

### Bequests

This is a gift you make by naming the Lighthouse Foundation in your will. If you already have a will, you may do this by a simple amendment.

### Life Insurance

You may choose to make the Lighthouse Foundation a beneficiary of your life insurance policy, or you may choose to gift your policy and receive an immediate tax benefit. Life Insurance is a way to leverage smaller current payments into a significant gift for the Lighthouse Foundation.

### Stocks and Securities

You may also donate stocks and securities to the Georgia Lions Lighthouse Foundation and avoid capital gains tax.

### Charitable Gift Annuity

A Gift Annuity is a contract between you and the Lighthouse. In return for a transfer of cash, marketable securities or other assets, the Lighthouse will agree to pay a fixed amount of money you for the rest of your life.

### Retirement Planned Gift

This is a gift made by naming the Lighthouse Foundation as the remainder beneficiary after your death and/or the death of your spouse.
